# **Recommendations for the Planning, Construction, Servicing and Operation of Public Swimming and Bathing Pond Facilities**

## **User Instructions**

Technical rules published by the FLL are freely applicable by anybody. An application obligation may result from legal or administrative regulations, contracts or other legal foundations.

FLL rulebooks are the result of voluntary technical-scientific teamwork. Due to the principles and rules adhered to within the scope of their development, they are to be regarded as professional rulebooks.
